**NOTICE OF RIGHT OF HEARING OR APPEAL  
UNDER SECTIONS 238(2) AND 242**

WHEREAS it appears to the Superintendent of Financial Institutions (the "Superintendent") that:

1. 609662 BC Ltd., dba Stop 'N Cash at 100A – 32660 Dahlstrom Ave, Abbotsford, British Columbia, under a franchise from Stop 'N' Cash 1000 Inc. (Ontario), is providing insurance policies as part of a payroll loan business.

AND WHEREAS the Superintendent is of the opinion that by the above acts or conduct, Stop 'N Cash, 609662 BC Ltd., and Stop 'N' Cash 1000 Inc. (Ontario), are committing an act or pursuing a course of conduct that does not comply with the Financial Institutions Act (the "Act").

AND WHEREAS the Superintendent considers, pursuant to Section 238(1)(b) of the Act that the length of time that would be required to hold a hearing would be detrimental to the due administration of the Act.

- 1 Cease from either directly or indirectly carrying on insurance business in British Columbia.

TAKE NOTICE THAT Stop 'N' Cash, 609662 BC Ltd., and Stop 'N' Cash 1000 Inc. (Ontario) have a right to a hearing or an appeal under Sections 238(2) and 242 of the Act.
