ORDER UNDER SECTIONS 244(2) AND 238, AND

**NOTICE OF RIGHT OF HEARING OR APPEAL
UNDER SECTIONS 238(2) AND 242**

WHEREAS it appears to the Superintendent of Financial Institutions (the "Superintendent") that:

- 1 International Insurance Group Inc. dba Mexico Insurance Professionals of Flagstaff, Arizona is not authorized to conduct insurance business in British Columbia; and
2. James Barrie Cartmell and Good Holiday Inc. are soliciting residents of British Columbia for insurance contracts on behalf of International Insurance Group Inc. dba Mexico Insurance Professionals.

AND WHEREAS the Superintendent is of the opinion that by the above acts or conduct, James Barrie Cartmell and Good Holiday Inc. and International Insurance Group, Inc., dba Mexico Insurance Professionals are committing an act or pursuing a course of conduct that does not comply with the Financial Institutions Act (the "Act").

AND WHEREAS the Superintendent considers, pursuant to Section 238(1)(b) of the Act that the length of time that would be required to hold a hearing would be detrimental to the due administration of the Act.

NOW THEREFORE the Superintendent orders pursuant to Sections 244(2) and 238 that:

1. International Insurance Group Inc. dba Mexico Insurance Professionals cease from either directly or indirectly carrying on insurance business in British Columbia.
2. James Barrie Cartmell and Good Holiday Inc. cease from either directly or indirectly soliciting residents of British Columbia for insurance contracts on behalf of unauthorized businesses, including International Insurance Group Inc. dba Mexico Insurance Professionals.

TAKE NOTICE THAT James Barrie Cartmell, Good Holiday Inc., International Insurance Group Inc. dba Mexico Insurance Professionals have a right to a hearing or an appeal under Sections 238(2) and 242 of the Act.
